### **Programme Overview**

The Master in Law and Economics of the Arab Region (MLEA) is a joint programme between the Faculty of Economics and Political Science (FEPS), Cairo University and the Institute of Law and Economics (ILE), Hamburg University.

MLEA offers a double degree; an M.Sc. from the Faculty of Economics and Political Science, Cairo University (Academic Master in Law and Economics (Specialization in Economics)) and an LL.M. from the Faculty of Law, Hamburg University (Master in Law and Economics of the Arab Region)

It provides students with the opportunity to be engaged with top academics from both faculties.

## **Programme Objectives**

The programme provides students with a cross-disciplinary approach to the study of law and economics and an advanced knowledge on the economic effects of divergent laws.

It enables participants to apply the tools of economics to legal problems and this intellectual orientation pervades the curriculum.

The programme prepares the degree holders for a career in public organizations or multinational law firms.

#### **Intended Learning Outcomes**

*After Completing the Programme, participants should be able to:* 

- Convey insights from Economic Analysis of Law (EAL) in a clear way to both specialized and non-specialized audience.
- Apply EAL in legal cases and to formulate policy opinions taking into account social responsibilities and possible economic impacts of different laws.
- Acquire the capabilities for pursuing additional studies autonomously. This includes, most notably, interdisciplinary research in legal and/or economic fields.







# Who can apply?

The minimum requirement for admission is a bachelor degree in Law or Economics. Applicants with a degree in Commerce, Business Administration, or other relevant social science field may also apply under the condition that the studied programme includes a substantial number of courses in Law and/or Economics.

### **Application Requirements:**

#### 1. Degree certificates

- A degree certificate stating that the student has successfully completed the listed programme and obtained the listed degree.
- An official transcript listing the grades obtained during the programme.
- 2. CV
- 3. Motivation letter
- 4. Two recommendation letters
- 5. Four personal photos
- 6. A birth certificate
- 7. Proof of English proficiency

(only for those who don't have a degree from a University programme entirely taught in English).

Test results must not be older than two years.

## **MLEA Programme Structure**

The programme covers 1.5 academic years, divided into a pre-master's phase and four semesters, where the students will receive 45 credit hours (90 ECTS points). In the second semester participants start their graduation projects under the joint supervision of FEPS and ILE professors. The third semester is held at the University of Hamburg, Germany. All courses are compulsory and are taught in English.

The pre-master's phase will start at the beginning of September followed by the first semester which will end by the mid of January. The second semester starts at February and ends by the mid of June. An obligatory third semester is spent in Hamburg in July/September. In semester four students write and submit their graduation projects.

# Internships

Due to the underlying business-partnership approach of the programme, all participating students should have prior practical experience. If they lack this experience, students should participate in an internship during their matriculation in this programme. Consequently, a limited number of fullyfunded internships, in the companies of the German or Egyptian business partners involved in this business-partnership-program, will be offered to the most outstanding students. These students will receive a certificate of participation from the partner university where the relevant business partner is located. All other students have to look for an internship possibility themselves with the support of the Coordinators of the program.
